Ed "Tiger" Verdin, City Public Relations Director, presented plaques to the winners of the Golf Cart Parade and Christmas Light Decoration Contest winners.

Ms. Beverly Domengeaux presented her yearly audit report for the St. Mary Council on Aging.

Evan Boudreaux introduced himself as the new Economic Development Director for St. Mary Parish. He expressed his eagerness to get St. Mary Parish and all its municipalities moving in a positive direction.

MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard said he was pleased with the Christmas season and the activities that were held even during the Covid-19 pandemic. The lights at Parc Sur la Teche, the Golf Cart Parade, and the Christmas Light Decorating Contest were all a success. He also mentioned that the All Crews Mardi Gras Parade is cancelled for 2021 due to the pandemic as supported by the crews.
