The Mayor and Council of the City of Franklin met in Regular Session on Tuesday, March 16, 2021, at 6:00 PM at City Hall, 300 Iberia Street, Franklin, Louisiana. Mayor Eugene P. Foulcard called the meeting to order. Also present were Councilmembers Chuck Autin, Larry Guilbeau, Joseph Garrison, Lester Levine, Jaime Robison, City Attorney Russell J. Cremaldi, and City Clerk Karen LeBlanc.

The invocation was offered by Mayor Foulcard and Councilman Chuck Autin led everyone in the Pledge of Allegiance.

GUESTS:

Stephanie Guidry, CEO, and Kevin Romero, Director of Marketing and Business Development with Franklin Foundation Hospital announced the addition of a Wellness Center to the Franklin Foundation Campus. The site will be the home to many medical and health services and is being constructed at a cost of \$19 million. A layout of the facility was displayed. Ms. Guidry also announced the future development of an urgent care facility across the street from the Wellness Center.

MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard thanked the Water Distribution Department and other City workers for working through prolonged freezing temperatures fixing water lines during the winter storm that was experienced in late February.

Mayor Foulcard read aloud the letter that accompanies the budget and discussed the reasoning for the increase in water rates by \$3.00 to \$11.00 per 1,000 gallons. He explained that city water is a bargain at \$0.011 per gallon compared to a gallon of bottled water costing anywhere from \$0.80 to \$1.29 a gallon. The rate increase is needed for the City of meet its debt obligations to the state and to help with making needed upgrades to the distribution system.
