The Mayor and Council of the City of Franklin met in Regular Session on Thursday, February 16, 2023, at 6:00 PM at City Hall, 300 Iberia Street, Franklin, Louisiana. Mayor Eugene P. Foulcard called the meeting to order. Also present were Councilmembers Chuck Autin, Joseph Garrison, Jaime Robison, City Attorney in Russel J. Cremaldi, and City Clerk Karen LeBlanc. Absent were Councilmembers Larry Guilbeau and Lester Levine.

The invocation was offered by Mayor Foulcard and Councilman Garrison led everyone in the Pledge of Allegiance.

GUESTS:

Mr. J. Ina, President of the 100 Black Men of St. Mary Parish promoted the 2023 Soul Food Festival

Ms. Debra Jones announced her candidacy for St. Mary Parish School Board District #4.

MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard read aloud his Budget Messages; copy of which follows these minutes.

DEPARTMENTAL REPORTS:

Mayor Foulcard stated that the City's Financial Statement for the month of December 2022 was presented to the council. He asked Mr. Hay to report on the amended and proposed budgets.

Mr. Ed Hay, Director of Finance, discussed the proposed amended and new budgets. He stated that he has met with the various departments about the budget and feels that the numbers appropriately reflect expectations.

Mr. Hay discussed the General Fund Amended Budget for Fiscal Year 2022-2023. First thing of note is that projected revenues are decreased from approximately \$7.6 million to \$6.4 million. Reduction is due to federal grants having to be revised due to timing of receiving the funds for the recreation centers HVAC units. The corresponding transfers of funds to Capital Outlay have been accordingly reduced. The other revenue items are projected to be relatively consistent in total with original projections. He stated that for the most part projections of expenses are expected to be between 2% to 6 % of the original projections with the exception of Public Works which will be 16% higher than originally projected due to the need to replace the tractor and bush hog. The City will be leasing a unit (approximate cost of \$90,000) over a five year period with option to buy. He anticipates the City will exercise the option as the estimated life of the unit is 20 years.

He stated that the revised revenue projections are fairly consistent with original projections – less than 2% variance. Expenses for the most part remained consistent except for insurance cost (33%) increase in premiums, utilities which is up 25% and repair and maintenance up by 58% due to aged instrumentation and valves which had to be replaced. The result is an expected reduction in profits of approximately \$120,000.

Mr. Hay discussed the Liquid and Solid Waste Fund. He stated that the revised income numbers show an increase of about \$100,000 due to anticipated increases in sewer sales tax collections. Unfortunately the increase in revenue is offset by a 24% increase in the cost of chemicals used and by an 85% increase in projected cost of repairs in the sewer collection department. The estimated cost of doing the appropriate rehab of the barrow street lift station is approximately \$88,000.

He stated that the budget for the capital outlay fund represents a reduction in transfers from the General Fund to cover the HVAC units for the Community Centers and of course the related expenditure has been removed. We also expected some movement on the Cayce street project but that has been moved into the next fiscal year due to preliminary estimates putting the project out of reach as configured. Revisions to the manner in which Cayce will be rehabilitated are in the works.

Mr. Hay discussed the Proposed Fiscal Year 2023-2024 Budget. He stated that in the General Fund what is proposed is an increase in total revenue of \$4 million. This is due to anticipation of receiving federal funds for the Community Center HVAC systems (\$1 million) and anticipated state grants for \$2.4 million for Cayce Street. The remaining \$1.2 million is anticipated financing proceeds to allow for construction of a fire training facility at Maurice Landry Park. He stated that it is anticipated that the state and the parish will provide the funding for the widening of the Yokely Canal. We also expect to see a 6% overall increase in sales tax given the current and projected condition of the economy.

Mr. Hay moved on to expenses. He stated that we are projecting expenses to remain consistent with the amended budget of Fiscal Year 2022-2023 with the exception that the transfers from the General Fund will reflect the funding that needs to be transferred to accomplish the Capital Projects. He stated that the Utility Fund is projecting a 9% increase in water revenue as the City gets closer to correcting all the problems with getting updated meters in place.

He stated that expenses in the Utility Department are anticipated to remain consistent with the Amended Fiscal Year 2022-2023 amounts with the exception of Repairs and Maintenance. Some repairs to various piping systems involved in the filtering process will have to be replaced in preparation for when the filter media will need to be replaced. That will probably be scheduled for Fiscal Year 2024-2025. The result of the increase in revenue less this additional cost is proposed to leave the fund with a profit of \$465,000 or 15% of revenue.

He stated that Liquid and Solid Waste Fund revenues are expected to be about \$200,000 above the amount proposed in the amended Fiscal Year 2022-2023 Budget. This is due to a projected 6% increase in sales tax and a similar 6% increase in garbage and landfill fees accomplished by the recent change in rates needed to remain consistent with the existing garbage contract. Expenses are expected to be consistent with the amounts shown in the amended Fiscal Year 2022-2023 budget. The one exception is that in Fiscal Year 2022-2023 the fund transferred out \$140,000 to the General Fund to assist in funding day to day operations. It is not anticipated that the fund will have to do that in Fiscal Year 2023-2024. That said we should expect that the fund will generate a surplus of approximately \$282,000 in Fiscal Year 2023-2024.

Mr. Hay closed with the proposed Capital Outlay Fund Fiscal Year 2023-2024 budget. He stated that the budget reflects the inflow of funds from the General Fund to facilitate the HVAC units for the Community Centers, the rehabilitation of Cayce Street, the construction of the Fire Training Facility and the widening of the Yokely Canal.

PUBLIC COMMENT (for items on the agenda): No comment heard.

BIDS:

A motion was made by Councilman Garrison to accept the Statewide Flood Control Program Resolution and Miller Engineers & Associates recommendation to award the contract for the Bayou Yokely Drainage Improvements bid to the lowest responsible bidder, Frisco Industrial Contractors, LLC.
