The Mayor and Council of the City of Franklin met in Regular Session on Tuesday, March, 21, 2023, at 6:00 PM at City Hall, 300 Iberia Street, Franklin, Louisiana. Mayor Eugene P. Foulcard called the meeting to order. Also present were Councilmembers Chuck Autin, Joseph Garrison, Lester Levine, City Attorney Russel J. Cremaldi, and City Clerk Karen LeBlanc. Absent were Councilmembers Larry Guilbeau and Jaime Robison.

The invocation was offered by Mayor Foulcard and Councilman Levine led everyone in the Pledge of Allegiance.

GUESTS:

Rev. Marty Harden, representing the Franklin Convocation of Pastors, announced the "A Week in the Word Campaign." He stated that the New Testament would be read in full in public throughout the parish during the week of April 2-9, 2023.

Mark Romero announced his candidacy for St. Mary Parish School Board District #4.

Whitney Bourque presented an item to the City from Franklin Masonic Lodge for the Bayou Teche Political Archive in tribute of Murphy Foster who was a member of the lodge.

Brittanee Davis announced the opening of Purpose Place Counseling & Consultation and provided information on the services her agency provides.

MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard presented his report. He stated that when Chief Beverly announced his retirement in November 2022, he had consultation with the City Attorney wherein the City's Civil Service Secretary contacted the Office of State Examiner – Fire & Police Civil Service to begin the process of administering the Police Chief's examination as required. Upon announcing the position available and setting a date for the examination eleven (11) applicants applied to take the examination. On January 19 the Police Chief's Exam was administered by the examiner with the Fire & Police Civil Service at City Hall. Seven (7) applicants were present for the test. The test results were received and accepted by the City's Civil Service Board on February 13. Six (6) Applicants passed the exam. He stated that the Civil Service Secretary contacted all six (6) applicants to begin scheduling interviews with himself, the Civil Service Board Chairman and City Council Members. All interviews were conducted in the first week of March. He stated he is still in the reviewing process of applicant references and employment history. As this is a major appointment for our city he wants to make sure he reviews each and every applicant thoroughly. He stated he has been in discussions with City Council Members to ensure the best candidate selected and will have the City Council's ratification at either a special meeting or regularly scheduled April meeting. Mayor Foulcard stated that he would like the public to know that the next Police Chief for the City of Franklin will be the best candidate to lead that department into the future.
