### MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard presented his report. He stated that after Chief Beverly tendered his retirement from the Franklin Police Department, he immediately called for the Civil Service Exam to be held. Eleven individuals submitted their applications to take the Civil Service Examination with six passing. All six were interviewed by me, two members of the Public Safety Committee, and two members of the Civil Service Board. After much vetting, deliberation and discussion between him and the councilmen on an individual basis, a few of the candidates rose above the others.

Mayor Foulcard stated that the position of Police Chief is one of seven department heads in the City of Franklin. He takes every appointment very seriously. He takes pride in the fact that the current department heads for the City of Franklin come together and work together as a team to keep things running smoothly and safely for our citizens. There is no "I" in team. While each department head has specific duties, the Police Chief is tasked with the safety and security of each and every citizen in the City of Franklin.

He stated that the chief is responsible for preservation of peace and order, prevention of crime, apprehension of criminals, operation of the police station, assistance to the courts and law enforcement officials as well as many other duties. But as equally important, our Chief of Police, along with his department must be vigilant and transparent with our citizens through community policing. At the moment, our city and nation are seeing the threats of gun violence like no other time in our history. He stated that he and the council both hear the cries and demands from our community for more to be done to combat gun violence. This has to be a two way street between the Franklin Police Department and the entire Franklin community and outlying regions. The Franklin Police Department cannot do this alone. It will take each and every one of us to combat the threats of gun violence we are seeing today. While the public is demanding more from our Police Department, he now demands more from our public.

Mayor Foulcard expressed that just the past weekend the St. Joseph community was stricken with gun violence that resulted in the loss of life of a young mother, Ms. Bryant. His thoughts and prayers are with her family and friends as they mourn a life cut short due to the senseless acts of those with a disregard for life.

He stated that until our community rises up together with local law enforcement, including the Franklin Police Department, can we battle the evils of society. Although this happened outside of the city limits, this still impacts the entire neighboring region. Enough is enough! Until the families of those doing wrong stand up and do what is right we will continue to see sporadic gun violence across our region. The community must work hand in hand with law enforcement. He prays each and every day for our community. He has put much thought and prayer into his decision as to who will be the next Chief of Police for the City of Franklin.

He stated that his prayers have led him to appoint Mr. Cedric Handy as Chief of Police for the City of Franklin and the appointment must be ratified by the Franklin City Council. Mr. Handy comes with over 20 years of law enforcement experience. His law enforcement career is well rounded, having a background of being a narcotics detective, swat team certified, active shooter instructor, crisis/emergency planning, as well as being a long-time community school resource officer for over 10 years. Mr. Handy holds an Associate's Degree in Business, a Bachelor of Science in Criminal Justice and is currently working on his Master's Degree in Criminal Justice

Mayor Foulcard then submitted Mr. Cedric Handy's name to the City Councilmen for their consideration as the next Franklin Chief of Police effective April 23, 2023.

Councilmembers Garrison, Autin, and Levine expressed their pleasure and support of the mayor's appointment.

He stated that the support of all those in attendance lets him know he has done something right.
